**NOTICE OF RACE**

**1 RULES**

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 No national prescriptions will apply.
- 1.3 The sailing instructions may also change some racing rules.
- 1.4 If there is a conflict between languages the English text will take precedence.
- 1.5 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing instructions, and supplementary sailing instructions will be available via email up until race day and on person

**2 ADVERTISING**

- 2.1 There are no advertising restrictions

**3\* ELIGIBILITY AND ENTRY**

- 3.1 The regatta is open to boats racing in PHRF.
- 3.2 PHRF classes will be divided according to rating and boat size and type. Non-Spinnaker will also be a class designation.
- 3.3 Registration will be on race day.

**4 FEES**

- 4.1 Required fees are as follows:
  - Members: \$20 Daily
  - Non-members: \$25 Daily
  - Season Pass Members: \$100
  - Season Pass Non-members: \$125

**5 SCHEDULE**

- 5.1 Registration: At skippers meeting
- 5.2 See race schedule on web site.
- 5.3 Morning buoy race / afternoon random leg course.
- 5.4 Skippers meeting 9:30am on the visitors center deck.
  - GPS start time at 11:00am - one start
  - Afternoon races - GPS start at 2:30pm

**8 MEASUREMENT**

- 8.1 Each boat shall comply with known one-design class and PHRF rules. .

## **9 SAILING INSTRUCTIONS**

9.1 The sailing instructions will be available on the BLYC Web site.

## **11 THE COURSES**

11.1 The courses to be sailed will be as follows:

All classes will race utilizing the existing BLYC Race Marks. Course to be announced at the skippers meeting and may be modified by VHF radio announcement on channel 6

## **12 PENALTY SYSTEM**

12.1 For all classes RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12.2 Decisions of the protest committee will be final as provided in RRS 70.5.

## **13 SCORING**

13.1 Low point scoring system will be used.

13.2 1 race is required to be completed to constitute a series.

13.3 There will be no throw outs.

## **14 SUPPORT BOATS**

Support boats for individual yachts are not permitted.

## **15 BERTHING**

Boats shall be kept in their assigned places while they are in the marina. Dry Sailed boats can arrange weekend berthing thru the park rangers.

## **16 HAUL-OUT RESTRICTIONS** None.

## **17 DIVING EQUIPMENT AND PLASTIC POOLS**

Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the regatta. [DP]

## **18 RADIO COMMUNICATION**

Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## **19 PRIZES**

Prizes will be given at the post race gathering on the visitors center dock.

**20 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

**21 INSURANCE**

Each participating boat shall be insured with valid third-party liability insurance.
